The Annualized Percentage Rate ("APR") of the Cash Out amount including Cash Advance Fee is calculated as follows: 6-month repayment period is 29.12%, 7-month repayment period is 28.10%, 8-month repayment period is 27.11%. Our Annualized Percentage Rate is calculated according to the standard of Hong Kong Association of Banks and is rounded to the nearest two decimal places. An APR is a reference rate which includes the basic interest rates and other applicable fees and charges of the product expressed as an annualized rate.
