Please note that the amendments on the “Investment eStatement Service Terms & Conditions” shall be binding on you if you continue using investment eStatement service of the Bank on or after the Effective Date. Should there be any discrepancy between the Chinese and English versions of this Notice of Amendment, the English version shall prevail.

A. Investment eStatement Service Terms & Conditions

Clause	Amendments (deletions are crossed out and additions are <u>underlined</u>)
First paragraph	Please note that the eStatement Service (as defined below) offered by China Construction Bank (Asia) Corporation Limited (the “ Bank ”) is subject to the following eStatement Service Terms and Conditions, in addition to the “Terms and Conditions for Online Banking Services”, “Terms and Conditions for Investment Services”, “Risk Disclosure Statements for Investment Services”, “Terms and Conditions in relation to Online Securities Trading Services” and any other terms and conditions related to online banking services or online securities trading <u>investment</u> services as agreed between you and the Bank from time to time (where applicable).
Item 1	The Bank has your authority and instructions to make available through the Bank’s Online Banking Services such securities trading <u>investment account</u> statements (the “ eStatements ”, each referred to as an “ eStatement ”) issued or provided by the Bank from time to time relating to your specified investment account(s) in electronic form for your access or use (the “ eStatement Service ”).
Item 21	If there is any inconsistency between the eStatement Service Terms and Conditions set out above, “Terms and Conditions for Online Banking Services”, “Terms and Conditions for Investment Services”, “Risk Disclosure Statements for Investment Services”, “Terms and Conditions in relation to Online Securities Trading Services” and any other terms and conditions related to Online Banking Services or online securities trading <u>investment</u> services as agreed between you and the Bank from time to time, the eStatement Service Terms and Conditions as set out above shall prevail in respect of the eStatement Service. If there is any discrepancy between the English version and Chinese version, the English version shall prevail.
