I/We agree hereby authorize the bank named overleaf to effect transfers from my/our account to the beneficiary named overleaf in accordance with such instructions as my/our bank may receive from such beneficiary from time to time.

本人/吾等明白任何更改或取消本授權書，須於更改/取消生效日期前最少四個工作天以書面通知方為有效。通知書並以背頁銀行收到為準。該通知書副本應由本人/吾等同時送予背頁之受益人。

I/We agree that any notice of cancellation or variation of this authorization which I/we may give to my/our Bank shall be given in writing at least 4 working days prior to the date on which such cancellation/variation is to take effect and such notice is only deemed to be served or given when the same is received by my/our bank named overleaf. A copy of such notice shall also be given to the beneficiary named overleaf by me/us.
