Notice of Amendments in relation to Credit Card Statements Revision at CCB (Asia) Credit Card Cardmember Agreement

Further to our nonfiction to you in April 2025 that the conditions for issuing statements for CCB (Asia) Credit Card Statements will be revised in the third quarter of 2025, we hereby write to inform you that, the relevant amendments have come into effect on 27 June, 2025. The revised conditions for issuing Credit Card Statements are as follows:

Clause 9.1 Statement of Account

- (i) A Statement of Account will normally be issued at monthly intervals unless there are no entries covering the relevant statement period and:
 - a. (Applicable to Visa and Mastercard Credit Card)
 Credit Card Account has a debit balance less than HKD10 or has a credit balance.
 - b. (Applicable to UnionPay Dual Currency Credit Card)

 Both HKD Credit Card Account and RMB Credit Card Account have their respective debit balances less than HKD10/RMB10 or has a credit balance.

You will not receive Credit Card Statement (including Paper Statement and e-Statement)
