## Making Early Repayment of CCB（Asia）Credit Card＂Chill＂Spending Installment Program

In general，more outstanding interest payments can be saved the earlier the loan is repaid．Nevertheless，the termination fee involved should also be taken into account before deciding whether to make early repaymen or not．The Bank uses the Rule of 78 for each monthly repayment of the apportionment of interest and principal in each monthly repayment．Even though the monthly repayment amount is the same throughout the loan tenor，more interest will be included in earlier repayments and less on principal．Where repayments have been made as scheduled for some time，the amount of outstanding interest is likely to be small．If early repayment is to be made at this point of time，the amount of interest saved may not be enough to cover the termination fee．Therefore before making a decision of repaying early or not，we suggest customers check with us the total amount involved in early repayment（including outstanding loan balance，termination fee and other charges，etc．）and the amount of outstanding interest，and then compare different scenarios and of the ca is for reference only．The details of actual repayment are subject to the Bank＇s final approval
